RioLINK <http://library.rio.edu> - Davis Library's Homepage and library network is a collection of different databases and services including [RioCat](#), the online listing of materials owned by Davis Library. RioLINK also serves as the gateway to OhioLINK, a network of Ohio university libraries and information resources. Most OhioLINK databases are available on your home computer via the Internet. To access these databases off campus: Your Barcode or Username is simply an “S” followed by your Student ID Number (Example: S123456). Your PIN is the last four digits of your Social Security Number (Example: 6789).

3. Editorials on File [R 070.44 E23] - From 1970 this contains information on specific news events followed by 10 to 15 related newspaper editorials. Use the index in the back of each volume.

18. Vital Signs [R 303.4905 V836] - This and the above are annual works published by worldwide watch groups that track the trends that may shape financial organizations.
19. Statistical Abstracts of the US [R 317.3 S797] - This is published every year by the Bureau of the Census and includes sections on just about any type of national business and financial activity. The index in the back refers to table numbers.
20. County and City Data Book [R 317.3 C855] - This is published about every five years and is intended as a supplement for the above that emphasizes data for counties.
21. State Profile: Ohio [R 338.9771 S797] - Similar to the above but is published annually by Woods & Poole Economics, a private organization.

To access the delivery service click on "Request Item". Follow the prompts. Your "Barcode" is simply an "S" followed by your Student ID Number (Example: S123456). Generally it takes two to three working days for books to be ready for you to pick-up at Davis Library's Circulation Desk. No notice of availability will be sent. Students may have books for three weeks and possibly renew the book four times. Charges will be levied for overdue or lost books.

1. Traditional Paper Encyclopedias – [Across from the Reference Desk] - Use the index in the last volume of any set to find relevant information efficiently.
2. Guide to American Law (Law Encyclopedia) [R 348.736 G946] - Use Court Case, Subject, and/or Name Indexes in Volume 12.
3. Guide to American Law Supplement [R 348.736 G946] - This is published every year to update the above. Use the indexes in the back of every volume.

4. Constitutional Law Dictionaries [R 342.73 C456] - Use the index in the back of each volume.
5. Encyclopedia of the American Constitution [R 342.73 E56].
6. American Heritage History of the Bill of Rights [R 342.73 A512] - The first ten amendments.
7. United State Supreme Court [R 347.7326 U58] - Use the index in Volume 10.
8. Encyclopedia of the American Legislative System [R 328.73003 E56].
9. Encyclopedia of American Crime [R 364.973 S573].
10. Law of Mass Communications [R 347.7326 T258].
11. Encyclopedia of American Journalism [R 070.03 P191] - One volume, use the index in the back.

Generally, in the RioCat Database, court case names will not work as words or subject headings. Instead, try related subject headings to browse through law books on the Second Floor like:

[Academic Search Complete](http://search.ebscohost.com/login.aspx?profile=ehost&defaultdb=a9h) <http://search.ebscohost.com/login.aspx?profile=ehost&defaultdb=a9h> - From 1984 to the present, this general periodical database indexes thousands of magazines and professional journals and newspapers and offers many full text articles.
2. [Readers' Guide to Periodical Literature](#) - *A traditional paper periodical index located in the middle of the Reference Collection* this indexes older periodicals from 1900 to the present. If your court case was decided before 1984: Use [Readers' Guide](#), although court case names themselves may not work as subject headings. Instead, use the yearly volume(s) of [Readers' Guide](#) when the case was most active and look under general headings related to the case. (Such as: UNITED STATES - SUPREME COURT - DECISIONS).
3. [New York Times Index](#) - This is also a traditional paper periodical index by [Readers' Guide](#) and covers the [New York Times](#), which Davis Library has on microfilm from the 1850's. Since this is cross-referenced so well, simply use the name of the court case in the appropriate yearly volume(s).
4. [LexisNexis Academic](http://www.lexisnexis.com/us/lnacademic) <http://www.lexisnexis.com/us/lnacademic> - A potpourri of full text information, this also indexes [The New York Times](#): full text from 1980 to the present and abstracts from 1969 to 1980. This might be an alternative to the above paper index.
